<u>Subject</u>: Guidelines for implementation of revised standard IS 4123: 2024 (incorporating amendment No. 01)

- 1. IS 4123: 1982 was revised to IS 4123: 2024 and in the revised standard, new sizes above 300 mm (i.e. 350 mm, 400 mm, 450 mm, 600 mm, 900 mm and 1200 mm) were added.
- 2. However, the test load which shall be applied to the wrench handle near its hand-grip end so as to produce the torque above 300 mm sizes were not specified.
- 3. Now, the Amendment No. 1 has been issued to IS 4123: 2024 and the test load which shall be applied to the wrench handle near its hand-grip end so as to produce the torque in case of sizes above 300 mm have been incorporated in the amendment. The last date of implementing the amendment is **20 Feb 2026**.
- 4. The major changes brought out in the Revised standard and subsequent Amendment No. 1 issued to IS 4123 are tabled below:

- 5. Consequent upon the revision and subsequent amendment to IS 4123: 2024, the Product Manual has also been revised and prepared as Product Manual Doc: **PM/ IS 4123/ 2 Sept 2025** and is being circulated separately through BIS website.
- 6. The guidelines for implementation of the revised standard IS 4123: 2024 (incorporating amendment No. 01) is given below:

A) LICENSEES

- i. Licensee shall implement the requirements of the revised standard IS 4123: 2024 (incorporating amendment No. 01) by 20 Feb 2026. Any difficulty in implementation shall be brought to the notice of CMD III within one month of issuance of these guidelines. BO shall ensure that no Licences are under operation as per old standard after 20 Feb 2026. The status of implementation of the revised standard shall be confirmed by Head (BO) to CMD-III within one month of the last date of concurrent running.
- ii. Licensees shall submit the conformity of additional nominal sizes through test report from BIS approved Labs. BO shall include all such nominal sizes as per guidelines in CSoL.
- iii. Verification of implementation of the revised standard IS 4123: 2024 (incorporating amendment No. 01) shall be done during the next surveillance visit, which shall be completed within one month from the date of submission of compliance by licensee.
- iv. If the Licensee fails to complete all actions by **20 Feb 2026**, it shall be dealt with as per the prevailing guidelines.

B) APPLICATIONS FOR GRANT OF LICENCE

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of revised standard. However, if the Applicant desires to get the licence with the revised standard IS 4123: 2024 (incorporating amendment No. 01), a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised standard IS 4123: 2024 (incorporating amendment No. 01), Licence will not be granted without revised standard.
- ii. Applications which are recorded henceforth may be processed with or without considering revised

standard. Processing of Applications without the revised standard IS 4123: 2024 (incorporating amendment No. 01) shall be permitted only upto **20 Feb 2026** and for such cases Applicant shall give a declaration that they will implement the revised standard by **20 Feb 2026**.

iii. After 20 Feb 2026, no Licence shall be granted without consideration of revised standard.

C) CHANGE IN SCOPE OF LICENCE

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- 7. The above guidelines come into force with immediate effect.
