Subject: Guidelines for implementation of Amendment no. 2 to IS 16513:2016 – (Agro textiles – Insect nets for agriculture and horticulture purposes – Specification)

1. Amendment no. 2 to IS 16513:2016 has been published. The amendment shall be implemented with effect from **15 April 2023**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

| 6.1 | Tolerances on length and width have been modified (made more liberal) |

3. There is no change required in the existing product manual on account of this amendment.
4. Since there is only a minor change to the standard through this amendment for making the tolerances more liberal, no evidence of conformity to the standard with amendment is required to be sought by BOs from licensees or applicants.
5. **However, All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.**
6. The above guidelines come into force with immediate effect.
