- 1. Existing IS 11569: 1966 'Specification for Cervical Collar' has been revised and published as IS 11569: 2023 'Cervical Collar Specification (First Revision)'. The last date of concurrent running of both the Indian Standards is 02 Feb 2024 (C-).
- 2. Currently there is only one licence for the product under LKBO. LKBO shall inform the Licensee under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. Any difficulty in the implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines.
- 4. The significant changes brought in the Indian Standard through the revision is listed in the Table below. LKBO is requested to ensure the compliance of the requirements as specified in the amended Indian Standard.
