Subject: Guidelines for implementation of revised IS 3383:2023 for Sulphur Wettable Powders — Specification to IS 3383:1982 for Specification for Wettable Sulphur Powder

1. IS 3383:1982 has been revised as IS 3383:2023 for Sulphur Wettable Powders — Specification and has been published. The last date for implementation of the revised IS 3383:2023 is **15th August 2023**, after which the old standard (IS 3383:1982) shall stand withdrawn.
2. As on date, there is 01 licence in operation under RJBO-2.
3. The significant changes in the standard through this revision as listed in the Table are given below for the purpose of general guidance. BO shall ensure that the product conforms to all the requirements, as applicable, as per the revised Indian Standard.

Clause No. of IS 3383:2023	Changes
3.2 (Table 1)	For the test requirements “Material passing through 45 micron IS Sieve” and “Suspensibility”, the words 'after accelerated storage' was deleted vide Amendment No. 2 of IS 3383:1982. This has been reincorporated into the revised IS 3383:2023 for these test requirements
5.1 (Marking)	Requirement of the following information to be marked on each container, has been modified: a) 'Net mass of contents' has been modified as 'Net quantity'; Following information is to be additionally marked on each container: a) Address of the manufacturer b) Date of expiry c) Any other information required under the Legal Metrology (Packaged Commodities) Rules, 2011

4. The existing Product manual has been revised to incorporate the changes due to the revised IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/3383/2, July 2023.

5. The guidelines for implementation of the revised IS are as given below:

A. LICENSEES:

- (i) The licensee shall implement the revised Indian Standard by **15th August 2023**. Any difficulty in implementation shall be brought to the notice of CMD-2 within 30 days from the date of issuance of these guidelines. BO shall ensure that no Licences are under operation as per IS 3383:1982 (old standard) after **15th August 2023**. The status of implementation of the revised Indian Standard, shall be confirmed by Head

- (BO) to CMD-II within two weeks of the last date of implementation of concurrent running.
- (ii) The licensee shall submit evidence of conformity to the marking requirements by **15th August 2023**.
 - (iii) If the Licensee fails to complete all actions by **15th August 2023**, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard. However, if the Applicant is desirous of considering the Application, as per the revised IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised IS, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old standard / the revised Standard. Processing of Applications as per the old Standard, shall be permitted only upto **15th August 2023**. For such cases Applicants shall give a declaration that they will implement the revised Standard by **15th August 2023**.
- (iii) Beyond **15th August 2023** no Licence shall be granted as per IS 3383:1982.

6. The above guidelines come into force with immediate effect.
