Subject: Guidelines for implementation of revised IS 1932:2022 to IS 1932:1986 for Mustard and Rape Seed Oilcake as Livestock Feed Ingredient- Specification

- 1. IS 1932:1986 and IS 1932:2022 for Mustard and Rape Seed Oilcake as Livestock Feed Ingredient - Specification are under concurrent running till 09<sup>th</sup> June 2023 and the last date for implementation of IS 1932:2022 is 09<sup>th</sup> June 2023, after which the old standard (IS 1932:1986) shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above revision and the amendment, within a week of issuance of these guidelines. Further, BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard IS 1932:2022.
- 3. The significant changes in the standard through this revision as listed in the Table are given below for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Indian Standard.

Clause No. of IS 1932:2022	Changes
Clause 4.2, Table 1	As per IS 1932:1986, the material was divided into 2 Types: a) Hydraulic or Expeller or Rotary Pressed Oilcake; and b) Ghani or Kolhu Pressed Oilcake. Hydraulic or Expeller or Rotary Pressed Oilcake was further subdivided into 2 Grades: (i) Grade HF (High Fat) and (ii) Grade LF (Low Fat)  However, in IS 1932:2022, Grade LF (low fat) [under hydraulic or expeller under hydraulic or expeller or rotary pressed oilcake] and Ghani or Kolhu pressed type oilcakes have been removed. Now the material is only of one type: Hydraulic or Expeller or Rotary Pressed Oilcake
Clause 4.2, Table 1	<ul> <li>a) Requirement for Aflatoxin B1, Castor husk and Mahua oilcake has been introduced in the standard</li> <li>b) Methods of tests prescribed for determination of crude protein, crude fat, crude fibre &amp; acid insoluble ash have been modified.</li> </ul>
Cl. 5.2.1 (Marking)	On each bag, the following is required to be additionally marked:  Best before date in month and year format

- 4. The existing Product manual has been revised to incorporate the changes due to the revised IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/ 1932/ 2, January 2023.
- 5. The guidelines for implementation of the revised IS is given below:

#### A. LICENSEES:

- (i) All Licensees shall implement the revised Indian Standard by **09**<sup>th</sup> **June 2023**. Any difficulty in implementation shall be brought to the notice of CMD-2 at the earliest. BOs shall ensure that no Licences are under operation as per IS 1932:1986 (old standard) after 09<sup>th</sup> June 2023. The status of implementation of the revised Indian Standard, shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation of concurrent running.
- (ii) Licensees shall submit evidence of conformity to the modified/additional requirement, through In-house/Independent Test Reports. Verification of the additional/modified requirements, shall be done by the BO preferably within 30 days of implementation of the revised IS by the licencee.
- (iii) If the Licensee fails to complete all actions by **09**<sup>th</sup> **June 2023**, as applicable, it shall be dealt with as per the prevailing guidelines.

## **B. APPLICATIONS FOR GRANT OF LICENCE:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard or the revised standard. However, if the Applicant is desirous of considering the Application, as per the revised IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised IS, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old standard / the revised Standard. Processing of Applications as per the old Standard, shall be permitted only upto **09**<sup>th</sup> **June 2023**. For such cases Applicant shall give a declaration that they will implement the revised Standard by **09**<sup>th</sup> **June 2023**.
- (iii) Beyond **09**<sup>th</sup> **June 2023** no Licence shall be granted as per IS 1932:1986.

## C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- 6. The above guidelines come into force with immediate effect.
