Subject: Guidelines for implementation of Revised IS 12492: 2025/ISO 5774: 2023 (Thermoplastics Hoses (Textile Reinforced) for Compressed Air — Specification).

1. IS 12492: 2023/ISO 5774: 2016 has been revised as IS 12492: 2025/ISO 5774: 2023 and has been published. The last date for implementation of the revised Standard is **22th October 2025** after which the old Standard shall stand withdrawn.
2. This revision has been brought out to align with the latest version of ISO 5774: 2023. The significant changes in the standard through this revision as listed in the Table are given for the purpose of general guidance.

Clause	Change
Marking 10 (b)	Editorial change has been made in marking with, b) the number and year of publication of this International Standard has been replaced by b) a reference to this document, i.e. ISO 5774 in place of ISO 5774:2016

3. Since only editorial correction has been made in this revision, no evidence of conformity for the revised ISS is required to be submitted and no change in scope of the licence is required consequent to the implementation of this amendment.
4. Consequent to the issuance of this revised ISS, the existing product manual has been revised which is being circulated separately.
5. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
6. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 21 October 2025.
7. The above guidelines come into force with immediate effect.
