Subject: Guidelines for implementation of Revised IS 13502:2023 (Pig Iron-Specification)

- 1. IS 13502:1992 has been revised as IS 13502:2023 and has been published. The last date for implementation of the revised Standard is **16**<sup>th</sup> **July 2023** after which the old Standard shall stand withdrawn.
- 2. As on date, there is only 1 licence operational under KKBO-II as per IS 13502:1992.
- 3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

	IS 228 has been replaced by IS 12308 (various parts) i.e. Chemical analysis of cast iron and pig iron as the test method for testing of Chemical Composition of Pig Iron.
Chemical Analysis of Pig Iron for Steel Making and	Requirement of Conformity of 500 micron IS Sieve to IS 460 (Part 1) (Specification for Test Sieves : Wire Cloth used for sampling Test Sieves) has been added to the relevant clauses i.e. A-1.2 and A-2.3

- 4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised. The same is being circulated separately.
- 5. The guidelines for implementation of the revised Standard is given below:

#### A. LICENSEE:

1. The Licensee shall implement the revision by 16<sup>th</sup> July 2023. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest but in any case, at least 30 days before the last date of implementation. The status of implementation of the revision shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.

- 2. Licensee shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable.
- 3. BO shall also plan an early surveillance visit, preferably within 30 days of switchover by the licensee, for verification of the implementation of the revised standard.
- 4. If the Licensee fails to complete all actions by **16**<sup>th</sup> **July 2023** it shall be dealt with as per the prevailing guidelines.

### B. APPLICATIONS FOR GRANT OF LICENCE:

- 1. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only up to 15<sup>th</sup> July 2023 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 16<sup>th</sup> July 2023.
- 2. Beyond 16<sup>th</sup> July 2023 no Licence shall be granted as per the old Standard.

## C. CHANGE IN SCOPE OF LICENCE:

- 1. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard or up to 16<sup>th</sup> July 2023 whichever is earlier.
- 3. The above guidelines come into force with immediate effect.
