Subject: Guidelines for implementation of amendment no. 1 to IS 5410: 2013, Cement Paint - Specification

- 1. Amendment No. 1 to IS 5410:2013 has been published with last date of implementation as 30 April, 2024
- 2. The significant changes in the standard though this amendment as listed in the Table are given for the purpose of general guidance.

Clause	Changes
clause F-2.1	Substitute the following for the existing paragraph:
	'Weigh accurately not less than 50 g of the sample and transfer to a 250 ml beaker. Mix the material to a thin paste with water. Thoroughly mix the contents of the beaker and break up all lumps with the flattened end of a stirring rod without grinding action. The test should be completed within one hour of making the paste as otherwise the material will thicken up in the process of setting.'

- As per the amendment, only the time of completion of the test has been changed. Since
 this does not require any change in manufacturing and testing capabilities, licensees and
 applicants shall be informed of this amendment immediately and advised to ensure
 compliance.
- 4. The above guidelines shall come into force with immediate effect.
