### **Subject: Guidelines for implementation of Revised IS 15768: 2025 (Textiles - Resistance to Ignition of Fire – Resistant Upholstery Fabrics for Use in Public Places – Specification)**

1. IS 15768: 2008 has been revised as IS 15768: 2025 and has been published. The last date for implementation of the revised Standard is **06<sup>th</sup> April 2026** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
3. The significant changes in the standard through this revision as listed in the Table are given for the purpose of general guidance:

Clause	Change
1	Scope of the Indian Standard has been modified and clarity on its applicability in different fields has been provided.
3	The definitions of upholstery fabrics, public places and composites have been incorporated.
ANNEX B	Classification of various occupancies into different degrees of hazard has been slightly modified.
5	Sampling criteria for Rolls and Pieces of Fire – Resistant Upholstery Fabrics have been separately defined.
6	The Marking requirements have been modified.

4. All of the changes to the standard through this revision are Non-technical in nature & clarification only. None of which require any evidence of conformity to the revised standard to be established.
5. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately (**PM/IS 15768/4 January 2026**). All BOs to align the scope of licence of the existing licences with the scope defined in the latest Product Manual.
6. In view of the above, BOs are requested to circulate this revised Standard to licensees and applicants immediately within 7 days of issue of this circular.
7. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the revised Standard after **06<sup>th</sup> April 2026**.
8. The above guidelines come into force with immediate effect.
