Subject: Guidelines for implementation of Revised IS 17265:2022 Textiles — 100 Percent Polyester Spun Grey and White Yarns — Specification

1. IS 17265:2019 has been revised as IS 17265:2022 and has been published. The last date for implementation of the revised Standard is **7 Nov 2022** after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Change
5.2	Requirement and test method for identification of material has been incorporated
Table 1	Table for examples of notation of textile yarns has been modified;
Table 2	Special characteristics of polyester spun yarn (PSF) has been modified;
Table 3 and 4	Table for physical and chemical requirements of polyester spun yarn has been modified
6.5	Clause for objectionable faults has been modified and method of test has been specified
6.3	Freedom from yarn defects has been modified;
7 and 8	Marking and packing clause has been modified

4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately.
5. The guidelines for implementation of the revised Standard is given below:

A. APPLICATIONS FOR GRANT OF LICENCE:

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- ii. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be

permitted only upto **6 Nov 2022** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **7 Nov 2022**.

iii. Beyond **7 Nov 2022** no Licence shall be granted as per the old Standard.

6. The above guidelines come into force with immediate effect.
