- 1. Amendment no. 2 to IS 14490 : 2018 has been published. The amendment shall be implemented with immediate effect.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
Foreword	It has been added in the foreword that "this standard covers the requirements for paper intended for photocopy purpose under the grammages prescribed in the standard. Paper under any other commonly used commercial names, such as multipurpose/ printing/ writing paper etc. in grammages except those covered in this standard are not intended to be used for photocopy purpose"
Table 1	For the requirement of ISO brightness a note has been added that "the requirement of brightness shall be applicable for white paper only"
6.1	Requirement for packaging has been modified (requirement for use of paper of minimum 80 GSM duly laminated for packaging has been removed)

- The existing Product Manual has been revised to incorporate the amendment and it is being circulated separately through BIS website, as the Product Manual Doc : PM/ 14490/3 July 2022.
- 5.
