Subject: Guidelines for implementation of revised IS 1159:2023 for Baking Powder — Specification to IS 1159:1981 for Specification for Baking Powder

1. IS 1159:1981 has been revised as IS 1159:2023 for Baking Powder — Specification and has been published. The last date for implementation of the revised IS 1159:2023 is **02nd December 2023**, after which the old standard (IS 1159:2023) shall stand withdrawn.
2. As on date there is 01 licence in operation under LKBO.
3. The significant changes in the standard through this revision as listed in the Table are given below for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Indian Standard.

3.3. and Table 1	Requirements for arsenic and lead have been revised

4 (Packing)	It has been mentioned that “The packaging material that comes into contact with the product shall be of food grade”
5.1 (Marking)	Requirement of the following information to be marked on each container, has been modified: a) ‘Net mass’ has been modified as ‘Net quantity’; Following information is to be additionally marked on each container: a) Brand name b) Address of the manufacturer c) Date of manufacturing or packing d) Date of expiry e) Directions for storage f) Directions for use g) Any other information required under the Legal Metrology (Packaged Commodities) Rules, 2011 and the Food Safety and Standards (Labelling and Display) Regulations, 2020
6 and Annex C (Sampling)	Sampling clause has been modified and a table (Table 2) has been introduced regarding no. of containers to be selected for sampling

4. The existing Product manual has been revised to incorporate the changes due to the revised IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/1159/2, August 2023.

5. The guidelines for implementation of the revised IS are as given below:

A. LICENSEES:

- (i) The licensee shall implement the revised Indian Standard by **02nd December 2023**. Any difficulty in implementation shall be brought to the notice of CMD-2 within 30 days from the date of issuance of these guidelines. BO shall ensure that no Licences are under operation as per IS 1159:1981 (old standard) after **02nd December 2023**. The status of implementation of the revised Indian Standard, shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation of concurrent running.
- (ii) The licensee shall submit evidence of conformity through In-house/Independent Test Reports tested as per the method of test given in the revised IS 1159:2023 and also submit declaration for additional Test equipments in Form 2.
- (iii) BO shall verify the documentary evidences submitted by the licensees for their compliance as per IS 1159:2023 and shall issue endorsement with regards to switchover to revised IS 1159:2023.
- (iv) Verification of implementation of the revised IS, shall be done during next visit, within 30 days of confirmation of implementation of the revised standard by licensee.
- (v) If the Licensee fails to complete all actions by **02nd December 2023**, it shall be dealt as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard. However, if the Applicant is desirous of considering the Application, as per the revised IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised IS, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old standard / the revised Standard. Processing of Applications as per the old Standard, shall be permitted only upto **02nd December 2023**. For such cases Applicants shall give a declaration that they will implement the revised Standard by **02nd December 2023**.
- (iii) Beyond **02nd December 2023** no Licence shall be granted as per IS 1159:1981.

6. The above guidelines come into force with immediate effect.
