Subject: Guidelines for implementation of Revised IS 9294:2023 (Cold Rolled Stainless Steel Strips for Razor Blades)

- 1. This has reference to the above.
- 2. IS 9294:1979 has been revised as IS 9294:2023 and the date of withdrawal of IS 9294:1979 is **03**rd **February 2024**.
- Presently, only one licence as per IS 9294:1979 is under operation at FRBO. FRBO shall communicate the revision of IS 9294:2023 to the licensee along with these guidelines immediately.
- 4. All BOs shall inform all the applicants under their jurisdiction about the implementation of the revised standard within a week of issuance of these guidelines.
- 5. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 6. Consequent upon the issuance of the revised Standard, the existing product manual of IS 9294 has been revised which is being circulated separately.
- 7. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

i) Licensee (under FRBO) shall implement the revised Standard by **03**rd **February 2024**. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest but in any case at least 30 days before the last date of implementation. FRBO shall ensure that the licence is not under operation as per old Standard after **03**rd **February 2024**. The status of implementation of the revised Standard shall be confirmed by Head (FRBO) to CMD-2 within two weeks of the last date of concurrent running.

ii) For switchover to revised standard, licensee shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports .

iii) FRBO shall plan an early surveillance visit for verification of the implementation of the revised standard preferably within 30 days of switchover by the licensee.

B. APPLICATIONS FOR GRANT OF LICENCE:

- 1. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- 2. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **02nd February 2024** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **03rd February 2024**.
- 3. Beyond 03rd February 2024 no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- 1. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard or up to 03rd February 2024 whichever is earlier.
- 3. The above guidelines come into force with immediate effect.
