- 1. Amendment no. 4 to IS 170: 2020 has been published. The last date of implementation of the amendment is **7**th **January 2026**.
- 2. The significant changes in the standard though this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amended Standard

Clause	Change
4.2.2	New clause 4.2.2 has been added at the end of 4.2.1 which is given below:
	For supplies of material in bulk, a test certificate shall be provided for each consignment.
3.3	Reporting of the specified requirement for Alkalinity has been substituted with "Not detectable" for "To Pass the test."

- 3. Since there are no changes in the requirement specified, no evidence of conformity for amendment no. 4 to the ISS is required to be submitted and no change in scope of the licence is required consequent to the implementation of this amendment.
- 4. The existing product manual (PM/ IS 170/6 August 2024) of the product already incorporates the Test Certificate. However, the PM has been revised with sub-contracting permitted for requirements with one-month frequency in SIT. The revised PM is being circulated separately, through BIS website
- 5. In view of the above, BOs are requested to circulate this amendment to the licensees and applicants for immediately within 7 days of issue of this circular.
- No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 07 January 2026.
- 7. The above guidelines shall come into force with immediate effect.
