Subject: Guidelines for implementation of revised IS 1712:2022 to IS 1712:1982 (Cottonseed Oilcake as Livestock Feed Ingredient — Specification)

- IS 1712:1982 and IS 1712:2022 for Cottonseed Oilcake as Livestock Feed Ingredient
 — Specification are under concurrent running till 30th June 2023 and the last date for implementation of IS 1712:2022 is 30th June 2023, after which the old standard (IS 1712:1982) shall stand withdrawn.
- 2. As on date there is only 01 licence for IS 1712:1982 which is operational under VJBO.
- 3. The significant changes in the standard through this revision as listed in the Table are given below for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Indian Standard.

	Now, as per revised IS 1712:2022, Grade 2 for both decorticated and undecorticated cottonseed oilcakes has been removed
Table 1, Cl. 4.2	a) Requirement for aflatoxin B1 has been introduced in the standard b) Methods of tests prescribed for determination of crude protein, crude fat, crude fibre & acid insoluble ash have been modified
5.1 (Packing)	Packing in HDPE bags have been introduced

- 4. The existing Product manual has been revised to incorporate the changes due to the revised IS and it is being circulated separately, through BIS website, as Product Manual Doc: PM/1712/ 2, January 2023.
- 5. The guidelines for implementation of the revised IS are as given below:

A. LICENSEES:

(i) On revision of IS 1712:1982 as IS 1712:2022 for Cottonseed Oilcake as Livestock Feed Ingredient — Specification, Grade 2 for both Decorticated and Undecorticated cottonseed oilcakes has been removed considering its poor quality as feed ingredient. Accordingly, the product has been differentiated into two grades: Decorticated Cottonseed Oilcake and Undecorticated Cottonseed Oilcake.

- (ii) The licensee shall implement the revised Indian Standard by **30**th **June 2023.** Any difficulty in implementation shall be brought to the notice of CMD-2 at the earliest. BO shall ensure that the Licence is not under operation as per IS 1712:1982 (old standard) after **30**th **June 2023**. The status of implementation of the revised Indian Standard, shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation of concurrent running.
- (iii) The licensee is required to declare the Type of Cottonseed Oil Cake as Livestock Feed Ingredient (i.e. Undecorticated cottonseed oilcake) as per Clause 3 of IS 1712:2022. The licensee is also required to submit an undertaking for free-gossypol content as per provisions of Clause 4.2 of IS 1712:2022.
- (iv) If the licensee intends to cover only Undecorticated cottonseed oilcake as per Cl. 3 of IS 1712:2022, he is required to submit evidence of conformity to the requirements of Crude protein, Crude fat, Crude fibre, Acid insoluble ash and Aflatoxin B1 through Inhouse/Independent Test Reports by **30**th **June 2023**.
- (v) BO shall verify the documentary evidences submitted by the licensee for their compliance as per IS 1712:2022 and shall issue endorsement with regards to switchover and revised scope of licence for Type: Undecorticated cottonseed oilcake as per IS 1712:2022
- (vii) Verification of implementation of the revised IS, shall be done by the BO preferably within 30 days of implementation of the revised IS by the licensee.
- (viii) If the Licensee fails to complete all actions by **30**th **June 2023**, it shall be dealt as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old standard or the revised standard. However, if the Applicant is desirous of considering the Application, as per the revised IS, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised IS, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old standard / the revised Standard. Processing of Applications as per the old Standard, shall be permitted only upto **30**th **June 2023**. For such cases Applicant shall give a declaration that they will implement the revised Standard by **30**th **June 2023**.
- (iii) Beyond 30th June 2023 no Licence shall be granted as per IS 1712:1982.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- 6. The above guidelines come into force with immediate effect.
