- 1. Amendment No. 1 to IS 4985:2021 has been published. The last date for implementation of the amendment is **01 Sep 2023**.
- 2. The change brought out in the Standard through the amendment is listed in the Table:

- 3. Consequent upon issuance of the amendment, existing Product Manual has been revised as Doc: PM/IS 4985/5/May 2023.
- 4. The amendment does not require any action by the applicants/ licensees towards its implementation. Licensee shall submit declaration w.r.t. manufacture of LF (Lead-Free) pipes.
- 5. In case any licensee intends to manufacture LF pipes, the inclusion of LF variety under the scope of licence shall be done as per the existing guidelines of change in scope of licence and the grouping guidelines of product manual. In case any applicant opts to cover LF pipes in their applied scope, the same shall be done as per the provisions given in the grouping guidelines of product manual.
- 6. All BOs shall inform the Applicants and Licensees under their jurisdiction about the above amendment immediately.
- 7. The above guidelines come into force with immediate effect.
