Subject: Guidelines for implementation of Amendment no. 1 to IS 17423:2021 – (Medical Textiles — Bio-Protective Coveralls — Specification)

- 1. Amendment no. 1 to IS 17423:2021 has been published.
- 2. This amendment has been issued to correct the limit specified for the requirement of Breathability (water vapour transmission rate) specified under Table 1 Requirements for Bio-protective Coveralls from "Max" to "Min".
- 3. IS 17423:2020 is currently under revision to IS 17423:2021. The (extended) last date of implementation of the revised standard is 12 Jan 2023 as already informed vide CMD-2's circular dated 20 Jul 2022. CMD-2 has also circulated the guidelines for implementation of the revised standard on 17 Nov 2021.
- 4. Since this amendment is a correction to the standard, BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
- 5. BOs shall also advise them to ensure that the evidence of conformity (test reports) to the revised standard to be submitted by them by 12 Jan 2023, as per above circulars dated 17 Nov 2021 and 20 Jul 2022, should indicate conformity of the product to the standard including amendment no. 1.

The evidences of conformity (test reports) if any already submitted by manufacturers for implementation of IS 17423:2021 shall also be reviewed to ensure that they meet the standard considering amendment no. 1.

6. The above guidelines come into force with immediate effect.
