<u>Subject</u>: Guidelines for implementation of Amendment No.1 to IS 8144: 2018 - Multipurpose Dry Batteries —Specification

1. Amendment No. 1 has been notified for IS 8144: 2018 – 'Multipurpose Dry Batteries – Specification'. The last date of concurrent running of the Standard with and without Amendment No. 1 is 09 November 2024.

2. The significant changes brought through this Amendment as listed in the Table below:

- 3. Consequent upon issuance of the amendment, the Product Manual has been revised as Product Manual Doc: PM/ IS 8144/2/ December 2023 and is being circulated separately through BIS website.
- 4. The guidelines for implementation of the Amendment is given below:

### A. LICENSEES

- i. The performance parameter requirement for 'Life Delayed Under Dry Heat Conditions (High Temperature)' test have been modified and updated for which the Licensee shall submit either In-house test report / BIS approved 3rd party Lab report for the varieties covered as per the grouping guidelines given in Product manual in order to establish conformity to the modified requirements.
- ii. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BO shall ensure that no Licences are under operation without Amendment after 09 November 2024. The status of implementation of the Amendment shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- iii. Verification of implementation of the Amendment No. 1 to IS 8144: 2018 shall be done through a surveillance visit, which shall be completed within one months from the last date of implementation.

iv. If the Licensee fails to complete all actions by 09 November 2024, it shall be dealt with as per the prevailing guidelines.

#### **B. APPLICATIONS FOR GRANT OF LICENCE**

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant desires to get the licence with the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
- ii. Applications which are recorded henceforth may be processed with or without Amendment. Processing of Applications without Amendment shall be permitted only up to 09 November 2024 and for such cases Applicant shall give a declaration that they will implement the Amendment by 09 November 2024.
- iii. After 09 November 2024, no Licence shall be granted without consideration of the Amendment.

#### C. CHANGE IN SCOPE OF LICENCE:

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii. However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the amended Standard or up to 09 November 2024 whichever is earlier.
  - 5. The above guidelines come into force with immediate effect.
