Subject: Guidelines for implementation of Amendment no. 1 to IS 16513:2016 – (Agro textiles – Insect nets for agriculture and horticulture purposes)

1. Amendment no. 1 to IS 16513:2016 has been published. The amendment shall be implemented with effect from **13 Sept 2022**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment within a week of issuance of these guidelines.
3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Change
4.2	In the requirement for netting fabric (raw material) used for making insect nets, the following alternative manner for marking the identification of manufacturer has been added — <i>For identification of manufacture, the name of the manufacture may also be provided at either selvedge of the fabric which shall also run through the complete length of the roll.</i>

4. Since the above change to the standard does not require any change to the product or the manufacturing or testing facilities, no evidence of implementation of the amendment needs to be obtained from licensees/applicants.
5. BOs are requested to please bring the above amendment to the knowledge of applicants and licensees.
