**Subject: Guidelines for implementation of revised Indian Standard and revised Product Manual as per IS 10805: 2022- Foot-Valves, Reflux Valves or Non-return Valves and Bore Valves to be used in Suction Lines of Agricultural Pumping Systems**

1. IS 10805: 1986 has been revised and published as IS 10805: 2022. The last date for implementation of the revised Standard is 28 February 2023.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard **within a week of issuance of these guidelines**.
3. The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

2.	Cl. 4.1	Obsolete grades of mild steel have been deleted and new grades have been added

4. Consequent upon revision of the Standard, existing Product Manual has been revised as Doc: PM/ IS 10805/ 2/ January 2023. In this revision of Product Manual, changes have been made in Grouping Guidelines, Scheme of Inspection and Testing (Definition of control unit has been modified, Levels of control for tests have been changed in Table 1).
5. The guidelines for implementation of the revised Standard is given below:

**A. LICENSEES:**

- (i) All Licensees shall implement the revised Standard by 28 February 2023. No changes in manufacturing or testing facilities are required, neither any test report is required for the changeover. **However, licensee shall implement and submit acceptance to revised SIT within 28 Feb 2023.** If the licensee fails to implement the revised SIT within stipulated time limit, it shall be dealt as per prevailing guidelines for non-implementation of revised Standard.
- (ii) No licence shall remain operative nor shall any licence be granted, as per old version after 28 February 2023. Endorsements for revision of Standard in the specified format shall be issued by BOs.

- (iii) Verification of implementation of the revised SIT, may be done during the next visit **which may normally be completed within one month from the date of submission of compliance by licensee or latest by three months from the last date of concurrent running.**

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per old Standard. However, if the Applicant is desirous of considering the application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the revised Standard, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per old or revised Standard. Processing of Applications as per the old Standard shall be permitted only up to 28 February 2023 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 28 February 2023.
- (iii) Beyond 28 February 2023 no Licence shall be granted without consideration of the revised Standard.

**C. CHANGE IN SCOPE OF LICENCE:**

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per old Standard shall be permitted only upto the date of implementation of the revision by the licensee or up to 28 February 2023 whichever is earlier.

6. The above guidelines come into force with immediate effect.
