Subject: Guidelines for implementation of Revised IS 6438: 2025 (Aluminium Phosphide Formulation — Specification).

- 1. IS 6438: 1980 has been revised as IS 6438: 2025 and has been published. The last date for implementation of the revised Standard is **17**th **July 2025** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The revised Standard has been brought out in the latest style and format of the Indian Standards, and references to Indian Standards wherever applicable have been updated. Further, all the amendments issued to the older version have also been incorporated in the Standard through this revision.
- 4. All of the changes to the standard through this revision are non-technical and editorial, none of which require any evidence of conformity to the revised standard to be established.
- 5. In view of the above, BOs are requested to circulate this revised standard to licensees and applicants immediately within 7 days of issue of this circular.
- 6. Subsequent to the revision of ISS, the existing Product Manual has been revised to align it with the revised version of IS 6438 & is being circulated separately (**PM/IS** 6438/2/May 2025).
- 7. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted as per the older version after 17th July 2025.
- 8. The above guidelines come into force with immediate effect.
