Subject: Guidelines for implementation of Amendment no. 2 to IS 3470:2017 (Hexane, Food Grade - Specification)

1. Amendment no. 2 to IS 3470:2017 has been published. The last date of implementation of the amendment is **28 February 2023**.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No. of IS 3470:2017	Changes
Page 11, Annex F	Annex F for Determination of Polycyclic aromatic hydrocarbons has been substituted with the following changes: i) Now 250 ml capacity separatory funnel required (earlier 125 ml capacity funnel was required) ii) Now it is specified that absorbance of the standard solution and test sample are to be measured in 5.0 cm quartz cell. iii) Now 75 ml of n-hexane and sample (earlier 25 ml) are required to be added in separating funnel. iv) Minimum time for which mixture is required to stand, has now been specified

3. Revised product manual incorporating the amendment is being circulated separately.
4. Through this amendment, there has been changes only in procedure for testing of Polycyclic aromatic hydrocarbons, which does not require the licencees to establish any evidence of conformity to the amended standard.
5. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
6. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the Amendment No. 2 after **28 February 2023**.
7. The above guidelines come into force with immediate effect.
