**Subject: Guidelines for implementation of Amendment no. 3 to IS 14490:2018 ( PLAIN COPIER PAPER — SPECIFICATION)**

1. Amendment no. 3 to IS **14490:2018** has been published.
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

<b>Amendment No 3</b>	
<b>Clause No</b>	<b>Change</b>
<i>Page 1, clause 5.3,</i>	The grammage (substance) of <i>65 g per square metre</i> of plain copier paper has been introduced with this amendment, in addition to the already available grammages of plain copier paper in the IS
<i>Page 1, clause 5.4)</i>	For 65 g per square metre of plain copier paper introduced with this amendment, the requirement of uniform thickness of paper has been specified as $\geq 90 \mu m$

3. There is no change in the prescribed requirement or in the test method for the different GSM of plain copier paper covered in the IS until this amendment, i.e., for 70, 75, 80 and 90 GSM of plain copier papers. Hence there no upgradation is required in the manufacturing and testing set up of the manufacturer.
4. The 65 GSM variety of plain copier paper introduced in this amendment, may be included in the scope of Licence on request of the Licensees, in accordance with the guidelines for Change in Scope of Licence.
5. BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issuance of this circular.
6. Revised product manual incorporating the amendments is being circulated separately.
7. The amendment no 3 shall be implemented by all licencees and applicants by 26 March 2023, No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of these amendments after 26 March 2023.
8. The above guidelines come into force with immediate effect.
