Item 0 GENERAL

0.1 Welcome

Shri Debasish Mahalik, Scientist-B/ Assistant Director, Food and Agriculture Department welcomed the Chairperson and members of FAD 22 to the 15th meeting of the committee. Shri Mahalik apprised the committee members regarding the various issues under consideration of the committee. Further, Shri Mahalik provided the brief report of the activities carried out under Agricultural Systems and Managements Sectional Committee, FAD 22 covering standard formulation, r & D activities, ISO liasioning and standards promotion. He also narrated the efforts made by expert members in completion of subjects undertaken for year 2023-24. Requesting for support from the committee, Shri Mahalik lauded the work done by the various members and urged for fruitful and conclusive deliberation on the issues raised in the agenda.

0.2 Opening Remarks by the Chairman

The Chairperson, Dr. P. K. Ghosh, Founder Director and Vice Chancellor, ICAR- National Institute of Biotic Stress Management, Raipur, in his opening remarks welcomed all members to the 15th meeting of Agricultural Systems and Management Sectional Committee, FAD 22 and requested all the members to extend active participation in the proceedings of the meeting. He informed about the taken up new areas in standardization and its importance in global as well as national level. He also advised the committee about more frequent meetings and preferably in physical mode. He also advised the members to express their views freely, good discussion and contribute their expertise for upgradation of standards.

ITEM 1 CONFIRMATION OF THE MINUTES OF THE FOURTEENTH MEETING

1.1 The committee noted that the minutes of the 14th meeting of Agricultural Systems and Managements Sectional Committee, FAD 22 held on 6 November 2023 were circulated vide our email dated 20 November 2023. As, no comments were received, the committee approved the minutes of 18th meeting without any further modification.

ITEM 2 SCOPE, ACTIVITIES & COMPOSITION OF THE SECTIONAL COMMITTEE

2.1 SCOPE & ACTIVITIES OF THE COMMITTEE

2.1.1 The committee noted the Scope and Program of Work (POW) of Agricultural Systems and Managements Sectional Committee, FAD 22 enclosed at Annex 1 of the aegnda and after due deliberation, the committee decided currently no more modification is required in the scope.

2.2 COMPOSITION OF THE COMMITTEE

2.2.2 The committee noted the received nominations from new co-opted member organizations and the updated composition of FAD 22 enclosed at Annex 2 of the agenda. The committee then decided that, failure to submit the nominations will lead to withdrawal of nomination of the organizations from the committee and will be recommended to Food and agriculture Division Council for final approval.

ITEM 3 FINALISATION OF ANNUAL ACTION PLAN FOR 2023-24

- **3.1** The committee noted the progress of the Annual Action Plan 2023-24 (enclosed at Annex 3 of the agenda) and appreciated the work done by members of FAD 18. As, all the actional points under Annual Action Plan for the year 2023-24 were completed, the Chairperson, FAD 18 appreciated the committee members, convenors, panel members for their dedicated efforts.
- **3.2** The committee noted the information provided under 3.2 of the agenda and analyzed the draft Annual Plan for Standardizations (APS) 2024-25 proposed by member Secretary, FAD 18 enclosed at Annex 5 of the agenda. After, due deliberation the committee decided the incorporate the following modification in the proposed APS 2024-25:
 - a) Removal of subject 'Contract farming' commercial farming' The committee after due deliberation opined that the standards on subject contract farming/ commercial farming

- requires specifications covering majorly legal and financial processes. Also, the due diligences of contract farming varies from cases to case basis depending upon type of crop, stakeholders involved, degree of legal compliances etc. therefore, considering the above, the committee decided to drop the subject from standardization under FAD 22.
- b) Removal of subject 'Guidelines for Agriculture 4.0, or Connected Farming' The committee after due deliberation, opined that the subject is very generic and it does not have any specific focus. Also, currently in India there is no or very little data available with respect to the subject. Therefore, developing a scientific standard will not be possible. Therefore, considering above, the committee decided to drop the subject from standardization under FAD 22.
- c) Removal of subject 'The cyber-agricultural system (CAS)' The committee after due deliberation, opined that the subject is very generic and it does not have any specific focus. Also, currently in India there is no or very little data available with respect to the subject. Therefore, developing a scientific standard will not be possible. Therefore, considering above, the committee decided to drop the subject from standardization under FAD 22.

The updated APS for the year 2024-25 approved by the committee with necessary modifications is enclosed at **Annex 1**.

ITEM 4 NEW STANDARDS FOR STANDARDIZATION

- 4.1 Doc. No. FAD 22 (22873) WC 'Requirements on Farming Practices and Labelling of Naturally Produced Products Natural Farming Production System'
- **4.1.1** The committee noted the information provided under 4.1.1., 4.1.2 and 4.1.3. After due deliberation the committee decided to temporarily halt the standardization activity regarding the above subject till further information received from Ministry of Agriculture & Farmers Welfare, New Delhi regarding approval of National Mission on Natural farming and further need for standardization of natural farming production system.

Further, the committee decided that after receipt of confirmation from Ministry regarding standardization activity on natural farming, the FAD 22/Panel III shall take up the comments/inputs

received (enclosed at Annex 5 to Annex 11 in agenda) and prepare the final draft for further circulation.

4.2 Doc. No. FAD 22 (23578) WC 'Integrated Pest Management - Requirements'

The committee noted that, the above draft Indian Standard (enclosed at Annex 12 of the agenda) has been circulated into wide circulation on 22 February 2024 for a period of 60 days seeking comments. The last date for submission of comments is 21 April 2024. Accordingly, the committee requested the members to provide comments on the draft standard, if any.

4.3 Integrated Nutrient Management – Code of Practice

The committee noted the information provided under 4.3 of the agenda and analysed the above draft standard (enclosed at Annex 13 of the agenda). After due deliberation, the committee decided to circulate the draft standard as preliminary draft (P-Draft) for a period of 21 days seeking comments from the committee members.

4.4 Integrated Management system for vermiculture

The committee noted the information and recommendation given under 4.4. After due deliberation, the committee requested the member Secretary, FAD 22 to deliberate the subject and its scope for standardization with Dr. S D Mishra, ICAR- IARI, New Delhi. Based on the recommendation of the deliberation, the subject will be taken up in next meeting of the committee.

4.5 Draft standards on Good Agricultural Practices:

- a) FAD 22 (02193) Requirements for Good Agricultural Practices India GAP Fruits and Vegetable Base (enclosed at *Annex 14*)
- b) FAD 22 (02197) Requirements for Good Agricultural Practices India GAP Livestock Base (enclosed at *Annex 15*)

Considering the recommendation of Member Secretary, FAD 22, the committee appointed Dr. Manish Pande, Director & Head PAD Division, Quality Council of India, New Delhi as convener of FAD 22/Panel I: Panel on Good Agricultural Practices.

The committee after due deliberation decided to send the two draft standards (FAD 22(02193) Requirements for Good Agricultural Practices - India GAP Fruits and Vegetable Base and FAD 22(02197) Requirements for Good Agricultural Practices - India GAP Livestock Base) to FAD 22/Panel I : Panel on Good Agricultural Practices (enclosed at Annex 14 and Annex 15) to FAD 22/Panel I : Panel on Good Agricultural Practices for further action.

Further, the committee requested Dr. Manish Pande, Director & Head PAD Division, Quality Council of India, New Delhi to convene an early meeting of the panel to take up the necessary deliberations related to above subjects.

Also, considering the national focus on natural farming, animal husbandry and integrated farming systems, this standard is going to be very helpful for different stakeholders.
2	Standardizing farming and agricultural practices of India	Rejected	The proposal is not specific and covers a wide area for standardization. There are existing standards and many are under development which covers aspects of farming and agricultural practices such as Good agricultural practices, organic farming, natural farming, integrated pest management, integrated nutrient management, precision farming technologies etc.
