**ITEM 0 GENERAL**

**0.1 Welcome by Head, Food & Agriculture Department, BIS**

The Member Secretary, Sh. Kuldeep Mittal welcomed the Chairperson and esteemed committee members in 20<sup>th</sup> meeting of Pesticides Sectional Committee, FAD 1. Mr. Mittal appreciated the work done by the various panel members since the last meeting and urged for fruitful and conclusive deliberation on the issues raised in the agenda.

**0.2 Opening Remarks by the Chairman**

Dr. J P Singh, Plant Protection Adviser and Chairman, Pesticides Sectional Committee, FAD 1 welcomed all the members of the Committee for participating in its 20th meeting. In his opening remarks he has stressed upon the importance of development of quality specifications of pesticides & its formulations and stressed upon the need to develop Indian Standards on all the registered pesticides including bio pesticides in the country. He has emphasized the need of updated specifications. He further requested the members for active participation in the deliberations and strive to resolve the comments received on various documents. The Chairman also suggested convening of the next meeting of the committee in the stipulated time so as to complete the work on the pending documents and take up new subjects for standardization.

**ITEM 2 R& D PROJECT PROPOSAL FOR "DEVELOPMENT OF TEST METHOD FOR TESTING OF BIO-PESTICIDES"**

**2.1** In 20<sup>th</sup> meeting, the committee deliberated on the ToR placed under Annex I of the agenda and the presentation delivered by Dr. Lakshman Prasad, Principal Scientist, Department of Plant Pathology, Indian Agriculture Research Institute, New Delhi. The committee discussed that the test methods related to bio-pesticides are already in the draft documents received by the BIS and these methods can be processed for validation. The committee requested FAD 1/Panel VII to organize the next meeting of

## **ITEM 7 COMMENTS ON INDIAN STANDARD**

**7.1 Comment on Indian Standard IS 15749 : 2007 Fluorinated HDPE bottles and containers – Specification**

In the 20<sup>th</sup> meeting, the committee deliberated on the query received from the Plastics Packaging Sectional Committee, PCD 21 regarding the use of fluorinated HDPE bottles and containers. The Committee clarified that the fluorinated HDPE bottles and containers are being used by the manufacturer.

### **ITEM 8 ANY OTHER BUSSINESS**

**8.1** Hon'ble Chairperson FAD 1 elaborated on the issue of pesticides registered for use in the country and available BIS of those products to ensure quality product supply to the farmers. He further added that more than 330 pesticides molecules are registered for use in the country with approximately 1000 formulations. Specifications of these products are required as on date for smooth and reliable testing of pesticides using unified single appropriate method of analysis. It was also deliberated that 310 Specifications could be published by BIS so far, therefore, the gap need to be reduced in a phased manner. The above said requirement is dynamic in nature as the registration of pesticides is omnibus.

He stressed upon the requirement of new BIS for pesticides and asked the participating member, institutes/labs etc. to submit a proposal for seeking financial support for validation of method of analysis required for formulating new BIS.

**8.2** The Chairperson also raised the issue of non-availability of standard on 'pheromones' used by the farmers. He said that the farmers are compelled to purchase unspecified quality of products due to absence of any standard for pheromones. He added that the use of pheromones through trap (except use of mating disruption) is not covered under regulatory framework registration through CIB&RC. Hence, there should be a standard on this to ensure that the farmers get a good quality pheromone products. The Chairperson added that there are some Institutes such as IISC Bangaluru, IICT Hyderabad etc. working on the pheromones. Also, Dr. Vipin Saini, CEO BASAI suggested BIS Secretariat to contact Dr. Markandeya Gorantla, ATGC Biotech, Hyderabad to give a brief presentation on use of pheromones pest monitoring. The Chairperson asked the committee members to work on the proposal and put before the Committee in next meeting.

**8.3** Also, Chairperson highlighted, that the macrobial (bio control agents) are not covered under the Insecticide Act, 1968 and this can also be considered as an area for standard formulation under FAD 1 and asked the committee members to work on the proposal and put before the Committee in next meeting. National Bureau of Agricultural Insect Resources (NBAIR), Bengaluru may be requested to contribute in the endeavour.

**8.4** Further, the Chairperson suggested that the BIS Secretariat to form a separate Sectional Committee or group of members on phytosanitary issue to formulate the National Standards to make the international trade easy and technically justifiable. In this committee/ group, there may be the members from different subject of expertise, BIS, Pesticides Sectional Committee, ICAR, State Govt., SAU's, other committees of BIS etc.
