NATIONAL FOREWORD

(Formal clauses shall be added later)

This standard prescribes requirements and methods of sampling and test for plastics graduated and ungraduated beakers for laboratory use. It is applicable to beakers having a tapered or a non-tapered form. The non-tapered form may, however, have a slight taper to facilitate mould release during manufacture.

The standard was originally published in 1982. While reviewing the standard, it was decided to revise this standard by adopting to ISO 7056: 1981 in order to maintain the uniformity in the product worldwide and also to facilitate the global trade.

The text of ISO Standard has been approved as suitable for publication as an Indian Standard without deviations. Certain conventions are, however, not identical to those used in Indian Standards. Attention is particularly drawn to the following:

a) Wherever the words 'International Standard' appears referring to this standard, they should be read as 'Indian Standard'.

b) Comma (,) has been used as a decimal marker, while in Indian Standards, the current practice is to use a point (.) as the decimal marker.
