(*Cover page, Title*) - Substitute the existing title by 'Solid Waste Management – Segregation, Collection and Utilization at Commercial Facilities (Shops and Shopping Complexes, Markets and Malls) – Guidelines'.

(*Page* 1, *Clause* 1, *Para* 1) – Substitute the following for the existing:

'This standard prescribes guidelines for segregation, collection and processing of solid waste (SW) generated at commercial facilities including shops and shopping complexes, markets and malls.'

(*Page* 2, *Clause* 3.5) – Insert the following new clause after 3.5

- **'3.6** Commercial Facility It means any facility that is used for retail stores, restaurants, office buildings, laundries, and other private business and service establishments or similar enterprises.'
- (Page 2, Clause **4.3.1**) Substitute the term "non-industrial biomedical waste" with "domestic biomedical waste"
- (Page 3, Clause 4.3.3, Line 5) Substitute 'may' for 'can'
- (Page 3, Clause 4.3.6) Insert the following new clause after 4.3.6.
- **'4.3.7** Construction and demolition waste if generated, has to be stored and handed over as per the guidelines provided by civic bodies/ Construction and demolition waste management rules 2016.'

(*Page* 4, *Clause* 4.4.2, *Line* 5) – Substitute the following for the existing:

'Vehicles used for transportation of wastes shall be covered and preferably should have a facility to compact and also prevent waste spillage and leachate dropping from the vehicles on the ground en-route to the processing or disposal facility.'

(Page 4, Clause 4.5.2) – Substitute 'may' in place of 'shall'.

(*Page* 4, *Clause* **4.5.3**) – Substitute the following for the existing:

'The waste picker shall further handover the hazardous waste to authorized agencies approved as per the instructions/rules/bylaws of Urban local bodies /Regulatory authorities.'

[Page 6, Annex A, Clause A-1 (d)]: Substitute the following for the existing:

'Expired solid, or liquid medicines, drugs and cosmetics'

[Page 6, Annex A, Clause A-2.1.1 (e)]: Substitute the following for the existing:

'Tub, tile, shower cleaners, shampoo bottles;'

[Page 6, Annex A, Clause A-2.1.2 (c)]: Substitute the following for the existing:

'Flea repellents'
