**NATIONAL FOREWORD**

This Indian Standard which is identical with IEC 60335-2-75 “Household and similar electrical appliances – Safety – Part 2-75: Particular requirements for commercial dispensing appliances and vending machines” issued by the International Electrotechnical Commission (IEC) will be adopted by the Bureau of Indian Standards on the recommendation of the Electrical Appliances Sectional Committee.

This standard was first published in 2018. This revision has been undertaken to harmonize with the latest version of IEC 60335-2-75:2012+AMD1:2015+AMD2:2018.

This standard covers the safety requirements of commercial dispensing appliances and vending machines.

It has been assumed in the drafting of this standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons. This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer’s instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IS 732: 1989 ‘Code of practice for electrical wiring installations (third revision)’ as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, in case of any deviation, wiring rules take precedence.

This part 2 is to be used in conjunction with IS 302-1: 2023, Safety of Household and Similar Electrical Appliances Part 1 General Requirements (Seventh Revision) [Doc: ETD 32 (22184)WC (*Under preparation*)].

NOTE 1: When “Part 1” is mentioned in this standard, it refers to IS 302-1.

This part 2 supplements or modifies the corresponding clauses in IS 302-1, so as to convert that publication into the Indian standard: Safety requirements for commercial dispensing appliances and vending machines.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2— The following numbering system is used:

- a) subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- b) unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- c) additional annexes are lettered AA, BB, etc.

NOTE 3— The following print types are used:

- a) requirements: in roman type;
- b) test specifications: in italic type;
- c) notes: in small roman type.

The text of IEC Standard has been approved as suitable for publication as an Indian Standard without deviations. Certain terminologies and conventions are, however, not identical to those used in Indian Standards. Attention is particularly drawn to the following:

- a) Wherever the words ‘International Standard’ appear referring to this standard, they should be read as ‘Indian Standard’.
- b) Comma (,) has been used as a decimal marker, while in Indian Standards the current practice is to use a point (.) as the decimal marker.

In this standard, reference appears to International Standards for which Indian Standards also exists. The corresponding Indian Standards, which are to be substituted, are listed below along with their degree of equivalence for the editions indicated:
