NATIONAL FOREWORD (Formal clauses will be added later)

This Indian Standard which is identical with IEC 60127-2:2014+Amd1:2020 'Miniature fuses – Part 2: Cartridge fuse-links' issued by the International Electrotechnical Commission (IEC) is proposed to be adopted by the Bureau of Indian Standards on the recommendation of the Fuses Sectional Committee and approval of the Electrotechnical Division Council.

This standard was initially published in 1989 and subsequently revised based on IEC 60127-2:2003. The second revision of this standard has been undertaken to align it with the latest version of IEC.

The text of the IEC Standard has been approved as suitable for publication as an Indian Standard without deviations. Certain conventions are, however, not identical to those used in Indian Standards. Attention is particularly drawn to the following:

- a) Wherever the words 'International Standard' appears referring to this standard, they should be read as 'Indian Standard'.
- b) Comma (,) has been used as a decimal marker, while in Indian Standards the current practice is to use a point (.) as the decimal marker.

In this adopted standard, reference appears to International Standards for which Indian Standards also exists. The corresponding Indian Standards, which are to be substituted, are listed below along with their degree of equivalence for the editions indicated:
