NATIONAL FOREWORD

This Indian Standard (Part 13) was originally published in 1988 and was identical adoption of ISO 5553 : 1980 'Meat and Meat Products — Detection of Polyphosphate (reference method)' under dual numbering. This first revision of the standard has been undertaken to harmonize with the latest version of ISO 5553 under development as document ISO/FDIS 5553 'Meat and meat products — Detection of condensed phosphates' and is an identical adoption of the ISO document under dual numbering.

The text of ISO Standard has been approved as suitable for publication as an Indian Standard without deviations.

Certain conventions are, however, not identical to those used in Indian Standards. Attention is particularly drawn to the following:

a) Wherever the words ‘International Standard’ appear referring to this standard, they should be read as ‘Indian Standard’.

b) Comma (,) has been used as a decimal marker while in Indian Standards, the current practice is to use a point (.) as the decimal marker.

The technical committee has reviewed the provision of the following International Standard referred in this adopted standard and has decided that it is acceptable for use in conjunction with this standard:

ISO 3696	Water for analytical laboratory use — Specification and test methods

In reporting the result of a test or analysis made in accordance with this standard, if the final value, observed or calculated, is to be rounded off, it shall be done in accordance with IS 2 : 2022 ‘Rules for rounding off numerical values (*second revision*)’.
