# 1 SCOPE

This standard provides requirements for double-ended uterine curette, Sim's pattern with both ends sharp.

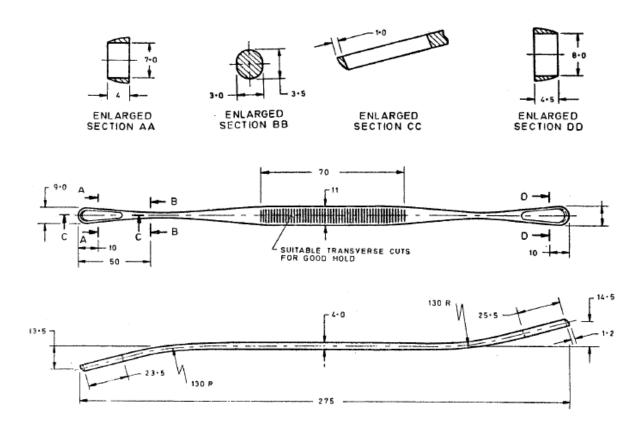

# 3 MATERIAL

The material shall be of stainless steel conforming to designation X22Cr13 or X30Cr13 as per IS 1570 (Part 5).

# **4 SHAPE AND DIMENSIONS**

The shape & dimensions shall be as shown in Fig. 1.

#### **5 WORKMANSHIP AND FINISH**

- **5.1** The surfaces of the curette shall be free from pits, dents, burrs, scales and other defects.
- **5.2** All the edges shall be even. The edges shall be rounded except the working ends, which shall be semi-sharp.
- **5.3** The curette shall be passivated and polished bright.

# **6 HEAT TREATEMENT**

The instrument shall be hardened and tempered to 400 to 450 HV measured as near to the working ends as possible.

# 7 TESTS

**7.1** Clamp the curette in a vice at the middle of the handle to its long axis. Suspend a load of 30 N gradually on one working end at a distance of 15 mm from the tip. Similarly carry out the test on the other working end. On completion of the test the curette shall show no sign of damage.

**7.2** Scrape with one working end of the curette a piece of 6-mm hard millboard quickly and vigorously to and fro 20 times with moderate degree of force. Similarly carry out the test with the other working end. The surface of the millboard shall be scraped easily and cleanly with both the ends, and on completion of the test the curette shall not show any sign of damage or distortion.

#### 7.3 Corrosion Resistance Test

Test the curette in accordance with IS 7531. The curette shall show no sign of corrosion after the test.

#### 8 MARKING

- **8.1** The product shall be legibly and indelibly marked with the following:
  - a) Manufacturer's name, initials or registered trade-mark;
  - b) Country of manufacture; and
  - c) The words 'Stainless Steel' or the letters 'SS'

# **8.2 BIS Certification Marking**

The product(s) conforming to the requirements of this standard may be certified as per the conformity assessment schemes under the provisions of the *Bureau of Indian Standards Act*, 2016 and the Rules and Regulations framed there under, and the product(s) may be marked with the Standard Mark.

#### 9 PACKING

The curettes shall be wrapped in moisture-proof paper or packed in polyethylene bags avoiding contact with one another.
