Application of the Standard can be tailored to fit specific requirements of the Organization, including the complexity of the system, degree of documentation, and resources. The Organization can derive direct financial benefits through implementation of ISO 50001. Further, as the standard is based on the common elements of ISO management system standards, its implementation can be well synchronized and integrated with the other Management System which the Organizations may have already adopted or planning to adopt.
